### The Client:

XML Securities, LLC is an introducing broker-dealer servicing retail clients. Its affiliate, XML Financial Group, is an investment advisor firm serving retail clients with a focus on traditional investment management and comprehensive financial planning. Most, but not all of the financial professionals, are dually licensed financial professionals. The combined entities have 35 employees.

### Business Challenge:

The Chief Compliance Officer (CCO) knew the process was going to be complicated and time-consuming, especially navigating the oversight of two firms and creating a separate RIA and BD Form CRS. The CCO had to begin by interpreting the SEC's 500-plus page rules document. There were other tools in the market and templates that had been circulated, but they were not tailored precisely to the firm's individual business requirements. How could CSS's Form CRS Automator build in customization and do enough work to be worth the investment?
